The term "Gross Receipts" as used herein is defined as those monies received by any person, firm, corporation, or association engaged in any occupation, business, trade, profession or other activity which, when received, constitutes income for state and/or federal income tax purposes. Specifically excluded from the term "gross receipts" shall be all monies received by a person in the employ of another, receiving either a pension, retirement, disability or annuity income, passive income from investments where said investments are not in the ordinary course of the person's occupation, business, trade, or profession.

\*\* Every employer who fails to file a business license tax return on or before the annual due date shall be subject to a penalty in an amount that equals 5% for each delinquent quarter or year. The total penalty shall not be less than \$25.00 per quarter or year.
